### INVITATION FOR BIDS

1. The Ceylon Electricity Board of Sri Lanka has applied for financing from the Asian Development Bank (ADB) toward the cost of **Green Power Development and Energy Efficiency Improvement Investment Program - Tranche 2**. Part of this financing will be used for payments under the contract named above. No nationality restrictions apply, other than any restrictions arising from ITB 4.7.
2. The **Ceylon Electricity Board (CEB)**, (“the Employer”), now invites sealed bids from eligible bidders for the Procurement of Plant - Design, Supply and Install for **Package 1 – Lot A** consisting of:

***Construction of Hambantota 220/132kV Grid Substation and  
Augmentation of 132/33kV Hambanthota Grid Substation***

Completion period is 730 days.

3. **International Competitive Bidding (ICB)** will be conducted in accordance with ADB's [Single-Stage: Two-Envelope](#) bidding procedure and is open to all Bidders without nationality restrictions.
4. Bidders are required to have satisfactory experience as main contractor or joint venture in at least three (3) contracts that have been successfully or substantially completed within the last ten (10) years and that are similar to the proposed contract, where the value of the Bidder's participation exceeds US\$ 12.4 million for each contract. The similarity of the Bidder's participation shall be based on the physical size, nature of works, complexity, methods, technology or other characteristics as described in Section 6 (Employer's Requirements of the Bidding Document). Bidder shall have minimum average annual turnover of at least US\$ 17.1 million, calculated as total certified payments received for contracts in progress or completed, within the last three (3) years.
