Ceylon Electricity Board intends to employ an Environmental & Social Safeguard Specialist on contract basis for implementation of Thermal Power Projects. Applications are invited from citizens of Sri Lanka having the Qualifications, Experience and Professional Competencies specified below and preferably having previous work experience in Environmental Management in similar type of projects on fixed term contract basis for the Project Division in CEB.

#### **Environmental & Social Safeguard Specialist – One (01) Vacancy**

##### **Qualifications and Experience:**

- First Degree in Biological Science, Environmental Science/Management, Social Science, Natural Resources Management, Forestry, Agriculture, Applied Science or any other related field of science obtained from a recognized University.  
AND
- Post Graduate qualification in Environmental Science or Environment Management obtained from a recognized university.  
AND
- More than 15 years' experience in Environmental Monitoring and Social Safeguard related activities (in which more than 10 years' experience should be in activities related to large scale infrastructure projects/ power plants etc.)
- Experience on foreign funded projects will be an added qualification.

**Age Limit** : Persons over 45 years will be considered only on exceptional grounds.

**Remuneration** : Based Management Service Circular 2019/01 dated March 15, 2019 issued by Department of Management Services – Ministry of Finance. (Depends on the qualification & experience)

**Mode of Selection** : Through an Interview among short listed applicants.

- Ability to function effectively in a team environment inspiring trust and co-operation of other team members of the Project.
- Ability to analyze and resolve implementation problems related to environmental and social safeguard in an effective manner.
- Good public relations skills.
- Computer literacy.
- Ability to communicate effectively.
- High level of proficiency in written and spoken English.
- Proficiency in written and spoken Tamil Language will be an added qualification.

##### **Terms and Conditions:**

- The appointment will be on contract basis for a period of two (02) years.
- The contract may be extended for a further term depending on the requirements of the Project. CEB reserve the right to extend or terminate the service as mention in the appointment letter.
- This appointment will not be considered as any future entry qualification for permanent cadre of CEB.
