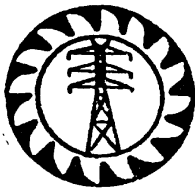

SPECIFICATIONS FOR SINGLE CAB TWO WHEEL DRIVE

1.0 General

The two wheel drive brand new single cab shall conform to the Motor Traffic Act of Sri Lanka. The vehicle should be forward control and right hand driven type. The make of the vehicle offered shall be well known and the offered vehicle shall be of latest model. The sole agent shall be well established in Sri Lanka with all facilities for after sale services. The sole agent shall ensure the adequate stock of spares and garage/workshop facilities. The vehicle shall be of heavy duty type suitable for use in tropical climate with seating capacity for 03 passengers including driver. The make of the vehicle offered shall have been used in Sri Lanka at least for five years. All components shall be fixed at the vehicle manufacturers factory.

2.0 Engine

Four cylinder, four stroke, radiator water cooled, in-line, overhead valve diesel engine with a displacement not less than 2300 CC and not more than 3200 CC. Minimum torque of 130 N.m shall be develop at maximum speed of 2500 rpm.

3.0 Transmission

Five speed forward and a reverse manual synchromesh transmission. Floor mounted gear shift and heavy duty single drive clutch plate.

4.0 Steering

Hydraulic power assisted steering system with tilt steering column and a steering lock.

5.0 Suspension

At front independent wishbone with coil springs or torsion bar with telescopic heavy duty type shock absorbers and at rear rigid elliptic leaf springs with telescopic heavy duty type shock absorbers.

6.0 Brakes

Hydraulic servo assisted front ventilated discs and rear self adjusting drum brakes with parking brake.

7.0 Wheels

At least 15 inches pressed steel single wheels for front, rear and spare wheel without locking ring. Tyres shall be of radial type with suitable tread pattern suit for rough terrains. An identical spare wheel (with type) with fixing arrangements shall be provided.

8.0 Seats

The driver's seat must be adjustable. All seats shall be of fabric finish. All interior exposed parts shall be suitably upholstered.

9.0 Body

Robust body suitable for rugged use with two lockable doors and cargo bed with tail gate. Weather protected front and rear bumpers, the cab guard and protective side body mouldings shall be provided. The rear cargo bed shall be suitably painted with corrosion preventive material.

10.0 Fuel Tank

Minimum capacity of 60 litres with lockable filling cap.

11.0 Standard Fittings

The vehicle shall have the following standard fittings.

1. 3 speed blower
2. FM Radio (frequency range 88-108 MHz) with Antenna
3. Clock
4. Seat belts
5. Cigarettes lighter socket & socket cover
6. Mud flaps
7. Full set of floor carpets
8. Sun visors for front passenger and driver
9. Both side view mirrors and rear view interior mirror
10. Windscreen washer
11. Two windscreen wipers with minimum of two speeds and intermittent operating facility
12. Cab interior lights
13. Electric horn
14. Halogen head lamps
15. Turning indicator lamps with hazard warning facility
16. Parking lamps
17. Reverse lamps
18. Reversing warning buzzer
19. Rear number plate lamp
20. Hand grips
21. Panel illumination

12.0 Instruments

1. Speedometer with odometer and trip meter.
2. Fuel level gauge.
3. Cooling water temperature gauge.
4. No/low battery charge indicator
5. Head light dip/beam indicator

6. Turning signal indicators
7. Hazard warning indicators
8. Parking brake indicator/ Break fluid low level indicator
9. Engine oil low pressure indicator

11. Glow lamp indicator

13.0 Electrical System

12 V/90 Ah (minimum) electrical systems with heavy duty battery, battery charging alternator with adequate capacity and starter motor.

14.0 Spares, Tools & Manuals

1. Spare wheel complete with tyre.
2. Wheel brace
3. Jack
4. Set of spanners, screw driver and pliers
5. Operation & maintenance manual in English

15.0 Warranty

Minimum warranty period of 12 months or 20,000 km which ever come first.

16.0 After Sales Services

The vehicle shall be of well known brand represented by a sole agent in Sri Lanka appointed by the manufacturer in order to maintain adequate spares, repair and service facilities for the single cab for at least 10 years period.

17.0 Other Technical requirements

1. Ground clearance of minimum 180mm
2. Minimum turning radius not more than 6.0m
