**SUPPLYING TOTAL OF 104MW OF SUPPLEMENTARY ELECTRICAL POWER ON SHORT TERM**  
**BASIS.**

1. On behalf of Ceylon Electricity Board of Sri Lanka, the Chairman, Standing Cabinet Appointed Procurement Committee of Ministry of Power & Energy invites proposals from eligible and qualified companies for the generation and supply of supplementary electrical power to CEB on short term basis under a Power Purchase Agreement (PPA).
2. The key parameters of this procurement are:
  - 2.1 Aggregate capacity requirement is 104 MW in 05 locations at Valaichchenai (24MW), Ampara (24MW), Habarana (24MW), Beliatta (8MW) and Mathugama (24MW) grid substations. CEB Lands are available at these locations to establish generation facilities.
  - 2.2 A Proposer can offer bids for one or more locations.
  - 2.3 The plant should commence commercial operation within 31 days from signing PPA.
  - 2.4 Term of this PPA will be 12 months.
  - 2.5 Tariff will be in two parts, one for capacity availability and the other for the energy dispatched.
  - 2.6 Selected proposers are responsible for procurement, delivery and storage of fuel and lubricating oil requirement for plant operations.
  - 2.7 Securing all the clearances/permits/licenses would be the responsibility of the selected proposers
3. Interested parties are requested to collect set of documents in English language titled "Request for Proposals for Supplying total 104 MW Supplementary Electrical Power on Short Term Basis" which outlines the requirements, specifications, process to be followed, selection criteria and general terms and conditions pertaining to this procurement
4. Proposers can purchase these documents from **December 26, 2019** at the address given below by paying a non-refundable fee of LKR 150,000.00 (Sri Lankan Rupees one hundred and fifty thousand). Proposals (Original and 3 copies) shall be submitted with a refundable proposal security in the amount of LKR 1,500,000.00 per MW (Sri Lankan Rupees one million five hundred thousand per Mega Watt) under sealed confidential cover before **10.00 a.m. Sri Lanka Time on January 16, 2020** at the address given below.
