1. The Democratic Socialist Republic of Sri Lanka has received financing from the Asian Development Bank (ADB) towards the cost of Supporting Electricity Supply Reliability Improvement Project. Part of this financing will be used for payments under the contract named above. Bidding is open to bidders from Eligible source countries of the ADB.
2. The Ceylon Electricity Board (CEB), ("the Employer"), now invites sealed bids from eligible bidders for the Procurement of Plant - Design, Supply and Install for Package 7 – Lot A3, consisting of:

Installation of: 124Mvar Breaker Switched Capacitor Banks in Colombo City Grid Substations and Replacing the Detuned Breaker Switched Capacitor Banks at Thulhiriya Grid Substation.

Completion period is 548 days.

3. **International Competitive Bidding** (ICB) will be conducted in accordance with ADB's Single-Stage, Two Envelope bidding procedure and is open to all eligible Bidders as described in the Bidding Document.
4. Bidders are required to have participation as a contractor, JV partner, or subcontractor, in at least two contracts that have been successfully or substantially completed within the last five (05) years and that are similar to the proposed contract, where the value of the Bidder's participation under each contract exceeds US\$ 2.36 million. The similarity of the Bidder's participation shall be based on the physical size, nature of works, complexity, methods, technology, or other characteristics as described in Section 6 (Employer's Requirements). Bidder shall have minimum average annual turnover of US \$ 6.9 million, calculated as total certified payments received for contracts in progress or completed, within the last three (03) years.
