A. General Conditions

1. Scope of Work

Ceylon Electricity Board (referred to as “CEB” in this document) Eastern Province intends to register Contractors for Way Leave Clearing – MV & LV Lines in Eastern Province from recognized registered contractors for a period of twelve months and extended up to another maximum period of three months, whenever such services are required.

B. Submission of Applications for Registration

1. Application for registration shall be submitted on or before 2.00 p.m. on **11/11/2020** to the Deputy General Manager (East), Ceylon Electricity Board, Nilaveli rd., Trincomalee. Duly signed "Certificate of Purchase of Application Document" should be submitted with the application.
2. Application shall be made on Original Forms and submitted in sealed envelope. The envelope shall be marked "**Application for Registration of Contractors for Way Leave Clearing – MV & LV Lines in Eastern Province - 2021**" on top left hand corner.
3. The name and mailing address of applicant shall also be indicated on the envelope.
4. The registration document, which is in English, shall be completed in English.
5. Application Form shall be completed fully. Additional sheets may be attached, if necessary. The Applicant shall sign each sheet. The DGM (East) reserve the right to seek clarification or request additional information from any applicant. Written answer to such clarification shall be submitted by the applicant within the period stipulated therein.
6. Any form of canvassing will result in the rejection on the outcome of the evaluation.
7. The Application may be accepted or rejected on the outcome of the evaluation based on documents supplied with the application.
8. Each applicant will be informed in writing whether his application be accepted or rejected.
9. Any contractor registered for Way Leaves Clearing for the year 2021 will be called for submitting bids as and when DGM (East) requires it.
10. However, DGM (East) reserves the right to call quotations from any other contractors if necessary.

C. Evaluation for Registration

Applications will be evaluated independently.

Experience, financial capability and past record of applicants will be considered in the evaluation.

Contractor's experience will be evaluated based on documentary proof of services provided to CEB during last five (05) years. Business experience of the contractor will also be considered.

Contractor's financial capability will be evaluated based on letters from reputed banks certifying their financial strength and credit availability, audited statements of accounts, bank balances etc.

Applicants shall be considered successful only if they achieve more than the minimum level of points determined by the C.E.B.

D. Invitation of Bids

When the CEB required to obtain the service, Invitation letters will be sent to all the pre-qualified contractors requesting to submit bids. The required bid documents could be purchased from relevant Area Electrical Engineer's Office by paying a non-refundable bid document fee as determined by the CEB.

Registered suppliers shall be abide by the General Bid Conditions given in the bid document.

E. Defaulting Suppliers

If a bidder fails to carry out his contract in a satisfactory manner, or is guilty of improper conduct, or does not respond to bids call for three consecutive quotations, or quote exorbitant prices to exploit C.E.B., the DGM (East) will serve him a written notice requesting him to show cause in writing within two weeks.

If the DGM (East) is not satisfied with the explanation furnished, action will be taken to remove his name from the register of contractors and the Bid Bond / Performance Bond will be forfeited and the contractor will be duly informed.

Defaulter may be placed on Province defaulters list by the DGM (East). This information will be communicated to other Province as well. Such contractors will not be registered in future for this services.
