- 2. However, if any Suppliers / Contractors already registered for some items for year 2020, willing to register for any other new item for the year 2021, they shall purchase the suppliers/ contractors registration document and submit the relevant applications for the new items/ services.
- 3. Separate application should be submitted for each category.
- 4. A complete set of registration documents containing applications for registration of suppliers and contractors shall be obtained on payment of Rs. 500.00 to Deputy General Manager office (East) (Address given below) on any working days till 10-11-2020 at 15 00 hrs. The payment shall be made by a CEB Pay in Voucher (PIV) or by bank draft written in favour of "General Manager, Ceylon Electricity Board" issued any commercial bank operating in Sri Lanka.
