  - (c) Meet the entire cost of grid interconnection of the power plant, including power transmission line, transformers, protection and metering equipment;
  - (d) Secure all environmental clearances, Government approvals and statutory licenses;
  - (e) Enter into a Power Purchase Agreement (PPA) with CEB for the supply of electricity (energy only) from the power plant. The Term of PPA will be 20 years beginning from the date of Commercial Operation.
- 2) A Project Proponent may submit more than one proposal for the grid substation listed above up to the total available capacity of that grid substation.
